Parashas Mishpatim - "Mishpat U'Tzedakah"

We find in Parashas Vayera the following justification for revealing to Avraham HaShem's intention to destroy Sodom: "For I have known him intimately, to the end that he may command his children and his household after him, that they may keep the ways of the L-rd, to do Righteousness and Justice; to the end that the L-rd may bring upon Avraham that which he has spoken of him." (Bereshis 18:19) This is immediately followed by "And Avraham drew near, and said: 'Will You indeed sweep away the righteous with the wicked? Perhaps there are fifty righteous within the city; will You indeed sweep away and not forgive the place for the fifty righteous that are therein? It is far from You to act in this manner, to slay the righteous with the wicked; it is far from You; shall the Judge of all the earth not act justly?' " (Bereshis 18:23-25)

Rashi comments at the beginning of Parashas Mishpatim, where the Torah discusses the Laws of the Hebrew Indentured Servant, "Just as those were given at Sinai, so were these." This statement seems, at first glance, somewhat absurd, for the Utterances include: "I am HaShem, your G-d..." (Shemos 20:2), "Remember the Day of Shabbos, to keep it holy..." (Shemos 20:8), "Honor your father and your mother..." (Shemos 20:12) These seem to be on a level far higher than the Laws of the Indentured Servant! But the explanation is simple; from the perspective of the Torah, there is no distinction between the loftiest of the Commandments, and those regarding honesty in business dealings. That is why the Sanhedrin, the Supreme Court of Jewish Law, which dealt with all aspects of Jewish Life, was co-located with the Temple, the earthly seat of the Divine Presence.

Ramban elaborates on the connection between the Ten Utterances and Parashas Mishpatim, as follows: "The essence of the 'Mishpatim,' is contained in the final one of the Ten Utterances, 'You shall not covet.' (Shemos 20:14) For, if one does not properly understand the private property status of a house, or a field, or other property, he will think that it is his, and he will desire it, and take it for himself. Therefore, the Torah said, '...place before them' (Shemos 21:1) fair laws regarding private property and put them into practice among them, and they will consequently not desire that which is not legitimately theirs. And so it says in Midrash Rabbah that 'the entire Torah is dependent on fair property law, and it was for that reason that the Holy One, Blessed Be He, placed the laws of private property right after the Ten Utterances.' " (Shemos 21:1)

Rabbeinu Yerucham gives an example of משפט, Justice, as understood in Jewish Law, the idea and the reality, as towering over Justice in non-Jewish legal systems. "A גוב, thief, who steals an ox or a sheep and sells or slaughters the animal, has to pay a סקנסר fine, of 'four or five' times the worth of the animal; four for the sheep and five for the ox. Rabbi Yochanan ben Zakkai explains that the Omnipresent takes into consideration the honor of his creatures, even the thieves. The thief probably had to carry the sheep! And this diminution of his self-respect is the reason for the diminution of his fine. But who ever heard of considering the self-respect of the criminal, as a factor in determining his punishment!?"

"ימשפט' הי אמתיי "The Laws of HaShem are Truth" (Tehilim 19:11). Divine Justice is Absolute Truth, without any compromise. "Anyone who says that the Holy One is a Compromiser should have his life compromised!" (Bava Kamma 50a) – (although the idea of הלכה, Jewish law). But nevertheless, they are permeated with consideration and mercy. Strict Justice combined with human consideration is the essence of Divine Justice. HaShem's Law is permeated to such an extent with human consideration that even the small consideration of the feelings of the has to carry the stolen sheep on his shoulder is not overlooked in the deliberations of the Justice of the Torah..." (Da'as Torah Shemos Mishpatim Pg. 228)
